This occurs via enhanced parasympathetic outflow to the sinoatrial node. Chemoreceptor feedback and changes in intrathoracic pressure also contribute to transient blood pressure modulation. These mechanisms are established in acute physiological studies yet show high inter-individual variability over longer periods.

Randomized trials demonstrate acute increases in HRV and reductions in self-reported stress following slow breathing guides.
