- Track serial measurements every 6-12 months to observe directional changes rather than single values.
- Discuss results within the context of overall health history and lifestyle factors with a qualified physician.
- Prioritize lifestyle variables like sleep, movement, and nutrition that influence multiple markers simultaneously before considering advanced testing.
- Escalate to a longevity-specialized clinician if multiple markers show consistent adverse trends over repeated tests.
